
Directions

From the north: Take I-75 to I-696 west; take exit 5 (Orchard Lake Road); turn right (north) and go 500 feet to 12 Mile; turn left (west) and go 1.4 miles to Oakland Center, which is on the left. From the northwest, take US 23 south to I-96 east (which becomes I-696); take exit 5 (Orchard Lake Road) and turn left (north); follow the rest of the directions above.

He received his BS from Buffalo State College and MA from Wayne State University, where he is currently pursuing a Ph.D His research interests and publications are in the area of dysphagia. His book, Manual of Dysphagia Assessment in Adults, was published by Singular-Thompson Learning in 1999, and was recently translated for publication in Japanese. Murray ha conducted numerous seminars and workshops at universities and hospitals in the United States, Canada and Europe.

Paula A. Sullivan, MS, CCC-SLP, BRS-S, is chief c Audiology and Speech Pathology at the William S. Middleton Memorial Veterans Hospital in Madison, Wisconsin. In addition, Sullivan is a clinical instructor in the Division of Otolaryngology and is an adjunct instructor in the Department of Communicative Disorders at the University of Wisconsin-Madison. Sullivan has more than 25 years of experience as an SLP. She has focused her clinical and research efforts on swallowing disorders in geriatrics and in individuals with head and neck cancer. Sullivan has been appointed to a Veterans Health Administration task force charged with making recommendations and developing national polic pursuant to the Office of the Inspector General's Report on Feeding and Swallowing. She is coauthor of Swallowing Intervention in Oncology and Easy-to-Swallow, Easy-to-Chew Cookbook, Sullivan is the former coordinator of ASHA's Division 13. Swallowing and Swallowing Disorders. She is an ASHA fellow.
